Operator/Manager's Report: JANUARY 2019 MANAGER/OPERATOR REPORT

1-7-19 went to Piedmont to pick up 30 gal of chlorine. It is too slippery at the pit to get a Hawkins Chemical truck there for delivery. I will probably need to pick up both alum & chlorine again if we don't lose the ice on the road by mid-February.

1-7-19 Water sample at Stepanek's.

1-16-19 New filters. 23 days, 676,700 gallons.

1-27-19 Creek riled up. Dwight left pump off all night.

Dwight back washed 8 days in January.

I got the bond application back from the insurance company and it is ready to be filled out and signed by an officer.

Signs are in at Summit Signs & I will pick them up soon.

January was uneventful, everything worked as it should.

For the pit water heater project, I have the faucet, Water Heater and expansion tank picked out. I will purchase them soon. It looks like a 19-gallon A.O. Smith water heater from Lowes about \$269.00, a faucet from Lowes about \$51.00 - \$89.00, and an expansion tank at Menards for about \$50.00.

A slightly less expensive faucet at Menards did not appear to be a quality faucet even though it was a name brand.

When I get all the parts I will probably have Precision Plumbing install them.

Pumped 909,703 gallons in January.

Bookkeeper's Report: Ron made a motion to approve the Treasurer's Report; Craig seconded. Motion carried unanimously.

<u>Minutes:</u> The January 14, 2019 minutes were reviewed. Rick made motion to approve the minutes; Penny seconded. Minutes were approved unanimously.

Old Business:

Power for Storage Unit/Building:

BH Electric will be hooking-up the power to the pole near the storage shed on 2/12/19 at a cost of \$1020.

Surety Bond for Excavation within the Public Right-of-Ways: Kathy Johnson from First Western Insurance Company provided an application to Scot for a License & Permit Bond in the amount of a \$5,000 Surety Bond. The application needs to be completed and then provided to First Western Insurance.

Summit Road Signs Cost: Scot placed the order with Summit for all the road signs needed. The signs are at Summit and Scot will pick-up on Tuesday, 2/12/19. Scot will also pick up some empty sand bags.

New Business:

Purchase of Certificates of Deposit: A \$50,000 11-month CD with a 2.25% APY (early withdrawal penalty of 3 months interest = \$281.25) and a \$200,000 17-month CD with a 2.40% APY (early withdrawal penalty of six months interest = \$2,400) were purchased at First Interstate Bank.

Rules & Regulation Revisions: The following changes were suggested:
Larry & Scot will put together their comments along with some information from Ron Gordon concerning recommended changes and e-mail a copy to all Board Members before the March meeting.

Manager/Operator Timesheets: Randy suggested that Scot fill out timesheets, which would give a better idea of time required to perform the duties of the Manager/Operator. Scot needs to provide information about how much time is spent doing certain tasks without accounting for every minute.

New Storage Unit Shelving: Randy asked if any shelves have been built & installed in the new Storage Unit? Scot has not put together any shelves in the storage unit. Scot suggested getting some of the heavy duty shelving from Sam's.

Misc:

Being no further business, Ron made a motion to adjourn; seconded by Penny. Meeting adjourned at 7:57 PM
