7-1-20 Water Sample @ Stepanek Residence

7-20-20 Monthly Report to DENR. Quarterly Report to DENR

7-9-20 Dave Wiege pumped out the Backwash Pit

7-14-20 Trimmed trees leading to Pit. Next trimming may need to be done by a professional tree trimmer. It is getting too high for me on a ladder in the back of a pickup.

7-15-20 Received Alum & Chlorine

7-15-20 Installed new Filters. 21 days, 1,032,308 gallons

7-21-20 Took tree branches to City Yard Waste dump site.

7-27-20 #3 pump went out when Dwight was back washing. (on rinse cycle) He could not get it to pump. I came down and tried to start the #1 pump. It would also not prime in. There was no air in the line so it could be an amp issue. Started the #2 pump

7-30-20 #2 pump quit 3 times during back wash when I switched valves. It quit last during flush of Harmscos. (24.8 amp) After back wash and pumping up the line the amps were 27.0. There may be an amp issue with the #2 pump also.

7-30-20 Sage Water Works installed a spare (overhauled pump) to replace the #3 pump. The #3 pump was last overhauled 4-12-16.

Dwight worked 6 days in July.

We pumped 1,376,594 gallons in July. My reading may differ slightly from Sage's reading because the meters store the meter reading as of midnight of the end of the month, and I read the meters around 7:00 AM on the 1<sup>st</sup>.

July was quite busy, with a few days needing 3 back washes.

Creek is lower than normal flow this time of year and is quite dirty.

#### **Bookkeeper's Report:**

Craig made a motion to approve the treasurer's report, Rick seconded the motion. Motion passed unanimously.

Past Due Accounts: Fred Jensen note to Marilee: "Sorry we are late ... We are struggling financially. Thanks" Marilee was wondering how she should respond. Board discussed the situation; Marilee should submit to the Board so they can decide how to handle.
