Randy called the meeting to order at 6:26 PM.

Operator/Manager's Report: January 2021; 2-1-21

- 1-5-21 Water sample at Donovan residence
- 1-7-21 Air in chlorine line. Could not purge. Replaced pump tube & roller assembly, purged air and restarted #3 pump.
- 1-15-21 Bad ice dam at 9:08 AM, creek overflowing banks next to pit. Water within about 6" of flooding pit. By 3:27 PM water started going over the dam again and the creek dropped 2 ½'. I do have photos if anyone would like to see them. This is 1st year I have ever seen Ice dams in all the years I have been in the water business.
- 1-16-21 Dwight changed filters. 12 days, 323,752 gallons. Ice dams are causing problems.
- 1-21-21 Water leak at 10025 Pioneer Avenue. Called Sage Water Works
- 1-21-21 Started running #2 pump again.
- 1-23-21 Sage Water Works fixed leak at 10025 Pioneer Ave. A 1" plastic barbed fitting cracked where it attached to the main. The repair went quite well.
- 1-23-21 Dwight changed filters. 7 days, 202,655 gallons.
- 1-29-21 Creek is starting to clean up.

Dwight worked 8 days in January, 2021

We pumped 841,190 gallons in January.

For the last 5 days of January, we pumped a below average number of gallons. (24,000 gallons per day) Average for December was 28,000 and for all of January was 27,000 gallons.

A berm should take care of the problem caused by the ice dam on 1-15-21; Scot is authorized to build the berm after it thaws.

The cost to fix the water leak at 10025 Pioneer Ave is the responsibility of HMWI.

Pump #3 is a 10-hp while the others are 15-hp except the pump recently overhauled.

Scot will have SD Rural Water check our system in the June/July 2021 time frame

Bookkeeper's Report:

Rick made a motion to approve the treasurer's report, Jane seconded the motion. Motion passed unanimously.
